## Broadband - High Speed Internet Access Service SUBSCRIPTION PRICES and SETUP CHARGES - 2016

**JTC Internet Service REQUIRES a Local Telephone Line** – An Internet Customer will NEED Local Telephone Service from **Johnson Telephone Company** in order to have Internet Access through **JTC Internet Service**.

**If Pre-Paying by the MONTH** – payment must be in our Payment Center on or before the 26<sup>th</sup> of the month for the “**Service Period**” beginning on the 27<sup>th</sup> of that Month and ending on the 26<sup>th</sup> of the following Month.

**If Pre-Paying by the YEAR** – payment must be in our Payment Center on or before the 26<sup>th</sup> of the month for the “**Service Period**” beginning on the 27<sup>th</sup> of that Month and ending on the 26<sup>th</sup> of the Month one Year later.

**NO REFUNDS** – once the “**Service Period**” begins.

**The Connection CHARGE applies in either of the following:**

- When a Subscriber (Customer) INITIALLY begins “**Service**”
- When a Subscriber, who has Discontinued “**Service**” for any reason, Reconnects “**Service**” at a later date
